- For Company check approval: a photo copy of your company check unless you are a "cash only" dealer
- Complete bank forms signed and stamped by a bank official
 *Note: this is only needed if you do not want to buy and/or sell on cash only basis

ATTENTION DEALERS

We at Mason Dixon Auto Auction are happy to have your business. There are however, policies that need to be addressed:

PAYMENT FOR VEHICLES PURCHASED: Our payment policy is that all vehicles purchased on a Tuesday night be paid for in full by the end of the day on Thursday at 4:00 P.M. After that time period has elapsed and payment has not been made, a \$50.00 late fee will incur on each vehicle. Also, if vehicles are not paid for and picked up by the following Tuesday, \$20.00 per day storage fee will begin to accumulate along with another \$50.00 late fee. We want you to know that your communication with us is very important and if there should be any problem with our payment terms, you should feel free to call and discuss this matter with us.

VEHICLES ON OUR LOT TO BE SOLD: Our Storage Fee Policy on vehicles on our lot to be sold. Once a vehicle arrives on our lot to be sold, if the vehicle runs through the sale every consecutive Tuesday and all registration fees are paid before the sale, no storage fees will be charged. However, if the vehicle is not run every consecutive Tuesday, and remains on our lot for 15 DAYS, starting on day 15 a \$20.00 per day storage fee will begin to accumulate on the vehicle.

ONLINE/SIMULCAST POLICY GUIDE

Please read and understand our policy guide for live (floor) auctions prior to buying and selling online.

We also require that you read and understand the policies set forth below as this is our simulcast policy addendum. Thank you for your cooperation and thank you for your business!

LIGHT SYSTEM

The structure of the light system online will remain very similar to that of our live auction and will be available on your screen when online bidding.

YELLOW Announcement- Any announced conditions will be shown on your bidding screen.

Title delay/absent

There is NO green light provided on any vehicle sold online through our simulcast sale.

All vehicles sold online will be sold AS-IS, with no guarantee or warranty. There is no arbitration on any vehicle sold via simulcast auction. It is the buyer's responsibility to make arrangements to physically inspect the vehicle prior to auction.

BIDDING

Please familiarize yourself with the computer bidding software on both your phone and computer prior to bidding. Should your bid be recorded as the high (winning) bid on any vehicle offered for sale, you <u>will own</u> the vehicle and payment *must* be completed the night of the sale, and it must be submitted electronically.

PAYMENT

Your prompt electronic payment is due the night of purchase. The following methods will be accepted as payment:

ACH

WIRE TRANSFER
DEALER FUNDING (NEXT GEAR, AFC, VAC, ETC.)

FEES

All existing fees assessed per each vehicle purchased at auction will apply to online bidding. An additional online buyer's fee of \$75 will be added to the buyer's total purchase price for each vehicle bought online.

STORAGE

Arrangements shall need to be made by the buyer to promptly remove the vehicle from auction within 48 hours (close of business the Thursday after Tuesday sale). Any vehicle not removed from the property after this period shall be charged at a rate of \$20 per day. Any vehicle removed from within the operations of the auction and parked in an exterior parking lot will be charged at the same rate of storage after the 48 hour window. No exceptions!
